**Subject:- Grant of Yearly Permission to Shri Motisingh Jageshwari Ayurved College & Hospital, Bada Telpa, Chapra, Saran- 841301, Bihar (Inst. ID-AYU0013) with intake capacity of 42 seats (instead of 60 seats) in UG (BAMS) course for the academic session 2025-26 under section 28 of NCISM Act, 2020 reg.**

Sir/Madam,

- To assess the available facilities of teaching, non-teaching, hospital staff, practical training and other infrastructure facilities at your college namely **Shri Motisingh Jageshwari Ayurved College & Hospital, Bada Telpa, Chapra, Saran- 841301, Bihar (Inst. ID-AYU0013)** inspection was conducted on **20.08.2025 and 21.08.2025 in hybrid mode** as a part of annual visitation by the visitation team of Medical Assessment and Rating Board, NCISM to process **the permission with intake capacity of 60 seats in UG (BAMS) course for the academic session 2025-26 under section 28 of NCISM Act, 2020.**
- The visitation report and all other related documents were assessed in terms of enforced regulations namely the Minimum Essential Standards, Assessment and Rating for Undergraduate Ayurveda colleges and Attached Teaching Hospitals Regulations, 2024", provisions under the NCISM Act, 2020 and relevant regulations thereunder. **On careful examination of the assessment report following shortcomings/defects have been observed:-**

## **1. Teaching Staff :-**

- Availability of total teaching staff for UG (BAMS) Course as per the part-1 submitted by the college is

- 3) In view of above, the assessment report was placed in the **143<sup>rd</sup> Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) on **26.08.2025**. On careful examination of the assessment report, considering the deficiencies observed therein as mentioned above, **the Board discussed and decided to provide an opportunity of clarification and the same was communicated to you vide letter of even no. dated 28.08.2025. In response of the same, you have submitted the clarification vide ref. no. 841/2025 dated 01.09.2025.**
- 4) Further, the assessment report along with clarification was duly placed in the **145<sup>th</sup> Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) **held on 02.09.2025 and Board observed that the college is not fulfilling the notified & requisite criteria for issuance of permission as per the Concerned Acts and regulations and also observed that college is not**



fulfilling the criteria in accordance with the Board's policy letter issued on 09.01.2025 & 20.01.2025 in UG (BAMS) course. Further the Board also observed that the college is not fulfilling the criteria for Extended Permission in accordance with regulation 54(2) of Minimum Essential Standards, Assessment and Rating for Undergraduate Ayurveda colleges 2024, as denial was issued to the college for academic year 2022-23. However, the Board decided to issue Yearly Permission as per the approved Seat Reduction Policy in accordance of Section 28(1)(f) of NCISM Act 2020 as the college has not followed the AEBAS guidelines as mentioned in Implementation letters vide ref. no. 3/2024/MARB/AEBAS and HMS dated 09.05.2024 and ref. no. 3/2024/MARB/AEBAS and HMS dated 06.09.2024.

As per the Penalization Policy adopted in accordance of Section 28(1)(f) of NCISM Act 2020 for Non/Improper/Delayed Implementation of Aadhaar Enabled Biometric Attendance System (AEBAS) in ASU College for the Academic year 2025-26:-

- a) "In cases of delayed or improper implementation of the Aadhaar Enabled Biometric Attendance System (AEBAS), the college shall subject to seat reduction by reducing 30% intake strength of total intake capacity."

**Therefore, for seat reduction in the intake capacity shall be considered by reducing the intake strength by 30% of total intake capacity.**

- 5) Hence, after applying the seat reduction policy 2025-26 under section 28(1)(f) of NCISM Act 2020 for **Non/Improper/Delayed Implementation of Aadhaar Enabled Biometric Attendance System (AEBAS) in ASU Colleges for the Academic year 2025-26**, the college is fulfilling the basic eligibility criteria for issuance of Yearly Permission with 42 seats (instead of 60 seats) in UG (BAMS) course in accordance with Regulation 54(3) of Minimum Essential Standards, Assessment and Rating for Undergraduate Ayurveda colleges 2024.

#### **"DECISION"**

- 6) Therefore, in view of shortcomings and deficiencies mentioned as above, **Shri Motisingh Jageshwari Ayurved College & Hospital, Bada Telpa, Chapra, Saran- 841301, Bihar (Inst. ID-AYU0013)** is hereby granted with, Yearly Permission with intake capacity of 42 seats (instead of 60 seats) in UG (BAMS) course in accordance with Regulation 54(3) of Minimum Essential Standards, Assessment and Rating UG Ayurveda 2024 for the academic session 2025-26, under section 28 of NCISM Act, 2020 subject to the condition that aforementioned shortcoming shall be fulfilled along with the following condition:-
- I. It is further informed that minimum **15% of undergraduate seats of the permitted intake capacity of 42 seats (instead of 60 seats)** shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2025-26 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.**
  - II. It is also informed that determination of fee and all other charges in respect of 50% of seats in private Medical Institutions and deemed to be University should be as per the guidelines issued by NCISM vide ref no. BUSS/Fee/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatory Committee (FRC) of respective State/UT/Deemed to be University.
- 7) Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
- 8) Further, **as per Sub-section (7) of Section 29 of NCISM Act, 2020**, The Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution and if the college is found to be not maintaining the Minimum Essential standards as specified in the concerned Acts & Regulations then **in accordance of Section 28 (1) (f) of NCISM Act, 2020 the issued permission of the college shall deemed to be withdrawn and denial of permission shall be issued by MARBISM for stoppage of admission for that particular academic year or the subsequent year.**
- 9) Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
- 10) **You are hereby instructed to comply with all the requirements of Aadhaar Enabled Biometric Attendance System as mentioned in the Implementation letters vide. ref. no. 3/2024/MARB/AEBAS & HMS. Dated 09.05.2024 & 06.09.2024 issued by the Board.**




11) The following requirements must be fulfilled and the compliance report must reach the Board by 31<sup>st</sup> December, 2025 to be considered for the issuance of permission for the academic session 2026-2027:-

- i) All the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled.
- ii) All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in NCISM (Minimum essential standards, assessment and rating for undergraduate Ayurveda colleges and attached teaching hospitals) Regulations, 2024.
- iii) All the requirements of the National Commission for Indian System of Medicine (Minimum Standards of Undergraduate Ayurveda Education) Regulations-2022.
- iv) The shortcoming mentioned in Para no. 2 above, shall be fulfilled.

12) In case if you are not satisfied with the decision of Medical Assessment and Rating Board, NCISM, you may prefer an appeal addressed to the Chairman NCISM, within 15 days of issuance of the letter as per Regulation 65 of MESAR 2024 and Regulation 29(5) of NCISM Act 2020.

13) The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college within the timeline as mentioned above to the President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission for the academic session 2026-27.
